PROHIBITORY ORDER U/S 163 BNSS

No.BAK/MAG-I/2024/180:: Whereas, due to picnic season large no. of people gathers at various picnic spots like Manas, Daragaon, Bhuta chowki etc. of Baksa district.

Whereas, use of loudspeakers and high volume, DJ sets, vehicle horn etc. disrupts the environment and natural habitat of the wildlife, which may lead to man-animal conflict.


Whereas, use of plastic bags, bottles cause environmental pollution and also disturbs the living environment of the wildlife.

Therefore, in order to protect the natural habitat of the wildlife and manage the crowd during picnic season in picnic spots. I, Shri Gautam Das, ACS, District Magistrate, Baksa, Mushalpur, in exercise of the powers conferred upon me under Section 163(1) BNSS do hereby prohibit the following in the district of Baksa-

1. Ban on high volume music, DJ sets at the picnic spots.
2. Ban on use of fire crackers at picnic spot.
3. Ban on plastic bottles, plastic bags in the picnic spots.

In view of urgency of the matter these order has been passed ex-parte and it shall come into force with immediate effect until further order.


