MINUTES OF THE MEETING OF DISTRICT DEVELOPMENT COMMITTEE OF THE MONTH
APRIL, 2023 OF BAKSA DISTRICT HELD ON 11/04/2023 AT 11:00 A.M. IN THE CONFERENCE
HALL OF OFFICE OF THE DEPUTY COMMISSIONER, BAKSA:

The meeting was chaired by Smti. Masanda M. Pertin, IAS, Deputy Commissioner, Baksa and at the very outset, she welcomed all officers present in the meeting. The Deputy Commissioner reviewed the progress of the developmental schemes department wise. After threadbare discussions, the following resolutions were adopted as mentioned below:

1. **e-Samiksha:** At the very outset, Deputy Commissioner, Baksa took a quick review on e-Samiksha and instructed all the HoDs to submit point wise report on e-Samiksha pertaining to their respective departments for uploading the same in e-Samiksha Portal.
2. **Orunodoi:** The Deputy Commissioner instructed all BDOs to prepare list of beneficiaries under DLMC Quota Circle wise for collection of Self-Affidavits under the leadership of Circle Officers.
3. **Agriculture:** The Deputy Commissioner instructed DAO to provide the updated status of Millers and Godowns in the district and also instructed to coverage door to door Paddy Procurement in the district. The DAO Baksa apprised the house that the 74% Farmers families have been receiving PM-KISAN benefits in the district. The DAO informed the house that 2023 has been announced as International Millet year and he also informed the house that in the district, demonstration on millets is going on especially of Fox tail millets.
4. **Education:** The Inspector of Schools apprised the house that 100% UDISE verification has been completed. The Deputy Commissioner instructed all Circle Officers to inspect the schools regularly. ADC I/c Salbari Sub-Division also requested all Circle Officers to inspect private Schools also.
Arohan :: The Deputy Commissioner informed the house that a counseling session will be held shortly at Barama College among Mentors and Mentees. DC instructed all Mentors to attend the counseling session for the successful implementation of Arohan Scheme in the District.
Vidyanjali: The Deputy Commissioner instructed LDM to communicate with the SBI LHO Guwahati as well as all Regional Head Quarters of the Banks under Baksa district to provide CSR fund for scheme Vidyanjali. The Deputy Commissioner instructed IS, BDC, Baksa cum DEEO to consult with the Tea Garden authorities under Tamulpur Sub-Division to provide Fans under CSR activities.
5. **DRDA:** The I/c PD, DRDA intimated the house that out 110 nos. of Amritsarovar, 86 nos. have been completed. DC instructed PD DRDA to consult with APDCL for issue of electric pole falling in the Amritsarovar Scheme and also to liaise with PWD (Roads) with regard to approach road to Amritsarovar Schemes as per the requirement. The Deputy Commissioner also instructed I/c PD DRDA for plantation of trees etc at the bank of Amritsarovar sites. The Deputy Commissioner also instructed I/c PD, DRDA to write a letter to the BTC authority for providing land for PMAY-G beneficiaries.
6. **Supply:** The Deputy Commissioner instructed I/c Deputy Director, FCS & CA for ensuring that every beneficiary under NFSA are registered under PMJAY and also instructed that it should be monitored by Area Inspectors by involving them constantly.
7. **Social Welfare:** Deputy Commissioner informed the house that out of 8(eight) nos. of Anganwadi Centres 7(seven) nos. of Anganwadi Centres have already been inaugurated at Barama LAC and out of 5 nos. of Anganwadi Centres, 2 nos. of AWCs have been inaugurated under Chapaguri LAC. She also instructed DSWO to expedite the process of 60 nos. of new Model Anganwadi Centres. DC also instructed DSWO, DLMC and Construction Committee to complete the process of rationalization of AWCs before DC, Conference. The Deputy Commissioner instructed DSWO in the 42 nos. of AWCs adopted by the District Administration, millet based snacks should be provided.
8. **PHE:** The Deputy Commissioner instructed all BDOs for early payment of remuneration to the engaged Jal Mitras. The Executive Engineer PHED informed in the house that fund proposal for Material Collection Facility (MCF) has been already submitted to the BTC authority for release of fund. After approval of fund from BTC authority, Material Collection facilities will be started soon for ODF villages. The Executive Engineer PHED said that the land for PWMU under Dhamdhama Block is suitable but the three phase electricity line connection is nearly about 1.5 Km. far from the construction site. The Deputy Commissioner instructed APDCL authority to prepare a Plan & Estimate for three phase line for set-up of PWMU at Dhamdhama Block.

9. Health: The Deputy Commissioner informed that PMJAY is a Flagship scheme of Govt. of India and Health department is completely responsible for distribution of PMJAY Cards amongst the NFSA beneficiaries. The JDHS is the Nodal Officer for PMJAY and she also instructed I/c Dy. Director FCS & CA, Baksa to cooperate with the Health department along with all field level officers from ASRLM and Social Welfare.
10. Excise: The Deputy Commissioner instructed Supdt. Excise to conduct raids in weekly markets of the district for stop of illegal liquor selling.
11. DTO:: The Deputy Commissioner instructed DTO to conduct frequent naka checking with the district enforcement team to reduce the accidents rate in the district.

The meeting ended with a vote of thanks from the Chair.
